

Court | Field Rentals

Reservations

Tennis | Pickleball court and field reservations should be made at least 48 hours in advance of the desired reservation date. A rental fee must be paid and insurance information provided where applicable. Reservations are posted onsite. If a court or field has not been reserved, it is available for public/small group use on a first-come, first-served basis. Parks & Recreation programs take precedence over drop-ins.

Deposits

Deposits are secured at the time of reservation to ensure proper clean-up, orderly conduct and compliance with park rules and regulations. Please have members of your group observe all posted rules and regulations. If there are damages or park policy violations, you may be charged an additional site impact fee or deposits may be withheld.

Cancellations

A cancellation fee may be assessed if court or field reservations are cancelled after the original request is confirmed, for reasons other than inclement weather.

Weather: Inclement weather refunds can be made by contacting the Parks & Recreation Administration Office the following business day after a reservation. **Call 970.962.2727 to see if parks staff has determined if the weather situation warrants a refund.**

\$5-\$12 Court, per hour

Field Rates Includes: grass turf, goal post line markers, goals and corner flags. Rates vary depending on field.

\$30-\$180 Preparation, per field
\$17 Field, per hour
\$120-\$200 Field, per day
\$15-\$20 Supervisor, per hour
\$17 Lights, per field/per hour
\$300 Clean-up



\$35 fee | \$35 deposit
Must be purchased at least five business days prior to the reservation date; permits expire at 10:00P on the day of the reservation.

Electricity

Electricity at shelters | pavilions is available with a paid reservation.

ADA Accessible

All shelters | pavilions are ADA accessible.

Reservations

Shelter | Pavilion reservations are made for the current year only, beginning on the first working day in January. They must be made at least five business days in advance of the desired reservation date.

All fees and deposits are due at the time of reservation. Changes must be made at least five business days in advance of the reservation date. The first change is free; all changes after that are subject to a \$10 service fee. Large groups of 151+ require Park Manager approval and are subject to an additional site impact fee. If a shelter has not been reserved, it is available for public use on a first-come, first-served basis.

Deposits

Deposits are secured at the time of reservation to ensure proper clean-up, orderly conduct and compliance with park rules and regulations. Please have members of your group observe all posted rules and regulations. Deposits are refunded within two weeks after the reservation, provided there are no damages or park policy violations.

Cancellations

Cancellations are assessed a **\$20 fee** and must be received at least ten business days prior to the reservation date in writing (or call 970.962.2727) by the person who made the original reservation, or all reservation fees will be forfeited. All attempts will be made to reschedule your date. If that is not possible, a refund of the fee and deposit (less the \$20 fee) will be issued within two weeks.
